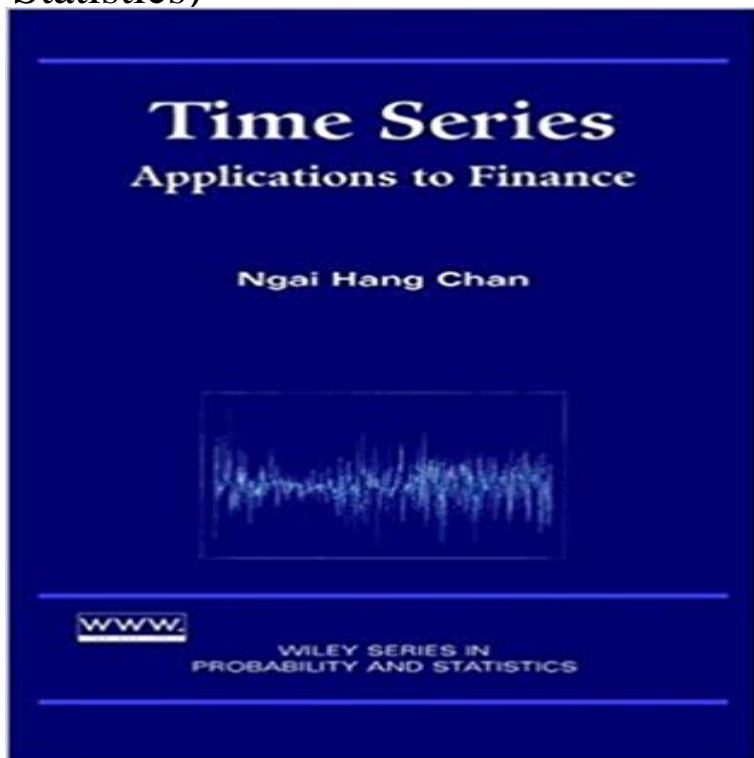


Time Series: Applications to Finance (Wiley Series in Probability and Statistics)
