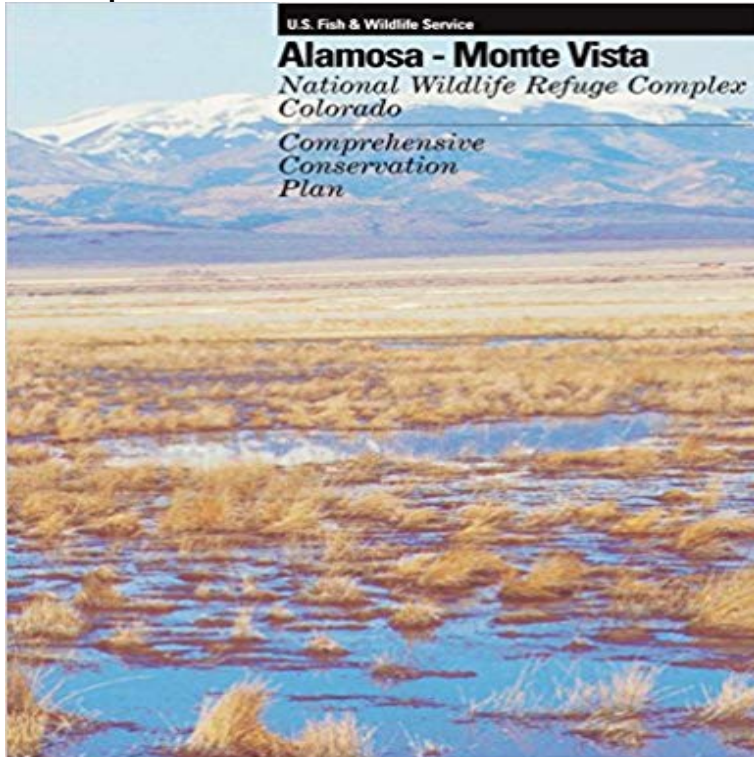


Alamosa - Monte Vista National Wildlife Refuge Complex Comprehensive Conservation Plan
