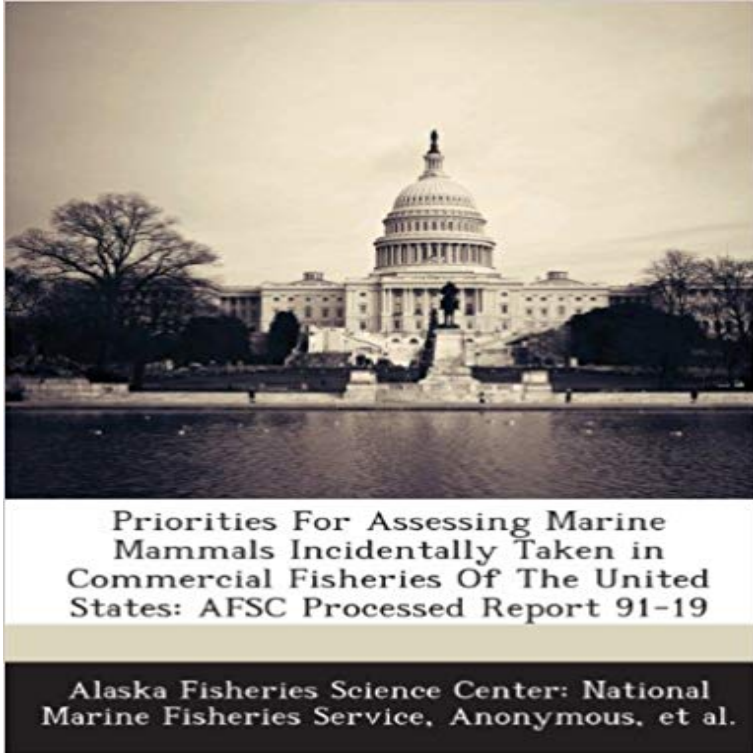


Priorities for Assessing Marine Mammals Incidentally Taken in Commercial Fisheries of the United States: Afsc Processed Report 91-19
